Project Description


The California Department of Transportation (Caltrans) proposes to relinquish seven segments from the Mooney Boulevard Six-Lane project along State Route 63 located in the City of Visalia. The post miles are 6.51 (segment 1), 7.01 (segments 2, 3, 4, and 5), and 7.51 (segments 6 and 7). All seven segments are curb, gutter, and sidewalks.

Determination

Caltrans has prepared an Initial Study for this project and, following public review, has determined from this study that the project would not have a significant effect on the environment for the following reasons.

The proposed project would have no effect on aesthetics, agriculture and forestry, air quality, biological resources, cultural resources, geology/soils, greenhouse gas emissions, hydrology/water quality, land use/planning, mineral resources, noise, paleontology, population/housing, public services, recreation, transportation/housing, and utilities/service systems.


In addition, the proposed project would have no significant effect on hazards and/or hazardous materials.

Figure 1 Project Vicinity Map




Figure 2 Project Location Map

The purpose of this project is to relinquish land (curb, gutter, and sidewalk) to the City of Visalia. The project would not result in an increase in greenhouse gas emissions. Also, no construction is required. While Caltrans has included this good faith effort in order to provide the public and decision-makers as much information as possible about the project, it is Caltrans determination that in the absence of further regulatory or scientific information related to greenhouse gas emissions and CEQA significance, it is too speculative to make a significance determination regarding the project's direct and indirect impact with respect to climate change. Caltrans does remain firmly committed to implementing measures to help reduce the potential effects of the project.

VIII. Hazards and Hazardous Materials (checklist question d)

Affected Environment

A hazardous waste evaluation was conducted on June 21, 2013. Five California Environmental Protection Agency Data Resources, commonly referred to as the *Cortese List*, were reviewed. The *Cortese List* is used by the State, local agencies, and developers to comply with the California Environmental Quality Act requirements in providing information about hazardous waste sites.




Figure 3 Segment/Parcel Map

In the project limits, State Route 63 is located in an urban area surrounded by commercial businesses. The original Mooney Boulevard Six-Lane Project consisted of a total seven segments (or phases). The parcels that require relinquishment are a result of the completion of the parent project. For more information on parcels and segment locations, please see Figure 3, Segment/Parcel Map. The parcels that require relinquishment are mostly curb, gutter, and sidewalks.

Environmental Consequences

Four parcels within segments 3, 5, and 7 are currently listed on the *Cortese List*. They are:

- Segment 3, Parcel #84775-2NTS (currently an In N Out Burger, formerly a Chevron Gas Station, 1933 South Mooney Boulevard). This parcel is listed as a Leaking Underground Storage Tank (LUST) site.
- Segment 5, Parcel #84806-2NTS (Weatherby's/Salmon's Furniture Guild, 2032 South Mooney Boulevard). This parcel is listed as a Leaking Underground Storage Tank (LUST) site.
- Segment 7, Parcel #84797-2NTS (Sierra Unocal 76, 1208 South Mooney Boulevard). This parcel is listed as a Leaking Underground Storage Tank (LUST) site.
- Segment 7, Parcel #84797-2NTS (Tosco Bulk Plant, 1821 West Tulare). This parcel is listed as a Leaking Underground Storage Tank (LUST) site.

One parcel is listed as a permitted Underground Storage Tank (UST) site. It is:

- Segment 4, Parcel #84805-2NTS (Flyer's Exxon, 1930 South Mooney Boulevard).

Avoidance, Minimization, and/or Mitigation Measures

The four Leaking Underground Storage Tank (LUST) sites are closed and were issued No Further Action letters from Tulare County Environmental Health and/or the Regional Water Quality Control Board. The one parcel that is listed as a permitted Underground Storage Tank (UST) site is not considered a hazardous waste risk for the purposes of this project. The remaining parcels contained within segments 1, 2, and 6 have no existing or previous hazardous waste risk. Therefore, no avoidance, minimization, and/or mitigation measures are required for this project.
