Ref: **AERONAUTICS ACCOUNT PENDING ALLOCATIONS**

At the October 2002 California Transportation Commission (Commission) meeting, the Commission took action to approve California Aid to Airports Program (CAAP) Funds for only safety projects and those projects for matching federal Airport Improvement Program (AIP) grants. The 2003/04 Budget Act appropriation transfers \$4.762 million from the Aeronautics Account. This transfer reduces CAAP funds and prohibits the Department of Transportation from recommending allocations for non-safety projects at this time.
