The California Department of Transportation (Caltrans) has completed the review of the following amendment to the Sacramento Area Council of Governments' (SACOG) 2008/09-2011/12 Federal Transportation Improvement Program (FTIP):

19 **State, Local, and Transit Elements**

- Adds, modifies or deletes various projects from various funding programs in El Dorado, Placer, Sacramento, Sutter, Yolo, and Yuba Counties. The amendment includes projects with funding from the American Recovery and Reinvestment Act (Recovery Act), Proposition 1B State Bond, State Transportation Improvement Program, Congestion Mitigation and Air Quality (CMAQ), High Priority Project, Regional Surface Transportation Program, Safe Routes to School and various Federal Transit Administration (FTA) programs.


SACOG has certified that the amendment is financially constrained and meets the requirements of public involvement procedures adopted by SACOG.
