The California Department of Transportation (Caltrans) has completed the review of the following amendment to the Santa Barbara County Association of Governments' (SBCAG) 2012/13 – 2015/16 Federal Transportation Improvement Program (FTIP):

5	Transit Elements

- This amendment adds and modifies projects in Santa Barbara County. It includes projects with funding from High Priority Project and Demo, State Transportation Improvement Program, Highway Safety Improvement Program, Transportation Enhancement Program, and local funds.

The updated programming is for projects in an air quality attainment area that is exempt from the conformity determination requirement. The SBCAG Board Resolution adopting this FTIP amendment certifies that the amendment is financially constrained and meets the requirements of public involvement procedures adopted by SBCAG.

Pursuant to the authority delegated to me by the Director of Caltrans, I approve SBCAG's Amendment Number 5. I also recommend that the Federal Highway Administration (FHWA) and the FTA approve this FTIP amendment for inclusion into California's 2013 Federal Statewide Transportation Improvement Program (FSTIP). Approval of this amendment does not constitute an eligibility determination of projects for federal funding.
